### **Early Sale Exemption:**

*Corn sold within 10 calendar days of delivery will have all Delayed Price charges waived.*

## **Important Reminders**

**On August 31**, any corn remaining in Delayed Price will be subject to **Upcoming Year New Rate Schedule**.

**All accrued DP charges will be billed to the patron's account on August 31 Yearly.**

If you are utilizing **Delayed Price** and **do not have a current agreement on file**, please request and return a completed agreement **within 10 days of delivery**.
